In consideration of being permitted to participate in this event sponsored by the Glenn County Sheriff's Posse (GCSP), I/WE do hereby waive, release and discharge any and all claims for damages for personal injury, death, or property damage which I/WE may have as a result of participation in this activity.

I/WE ACKNOWLEDGE THAT HORESBACK RIDING AND JUNIOR RODEO IS A SPORT WHICH CARRIES INHERENT RISKS OF INJURY TO MYSELF, MY HORSE AND PROPERTY. KNOWING THIS, I/WE ASSUME THOSE RISKS, WHETHER KNOWN OR UNKNOWN, WHICH ARISE FROM HORSEBACK RIDING AND JUNRIO RODEOS.

I/We further agree that this waiver, release and assumption of risk is to be binding on my heirs, executors, and assigns.

I/We expressly waive any rights we may have under California State Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know about, or suspect to exist in his favor, at the time of executing the release, which, if known, might have materially affected his settlement with the debtor."

I/We agree to indemnify and hold harmless the GCSP (including all officers, directors, agents, members and employees) and Land Owner and Lessees of Land Owner from any loss, liability, damage, cost, demand, claim, or expense which may be incurred as a result of my participation in this event. This includes all court costs and actual attorney fees arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.

I/WE ACKNOWLEDGE I/WE HAVE CAREFULLY READ THIS AGREEMENT, WAIVER AND RELEASE, AND FULLY UNDERSTAND ITS CONTENTS. I/WE ARE AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE GCSP.
