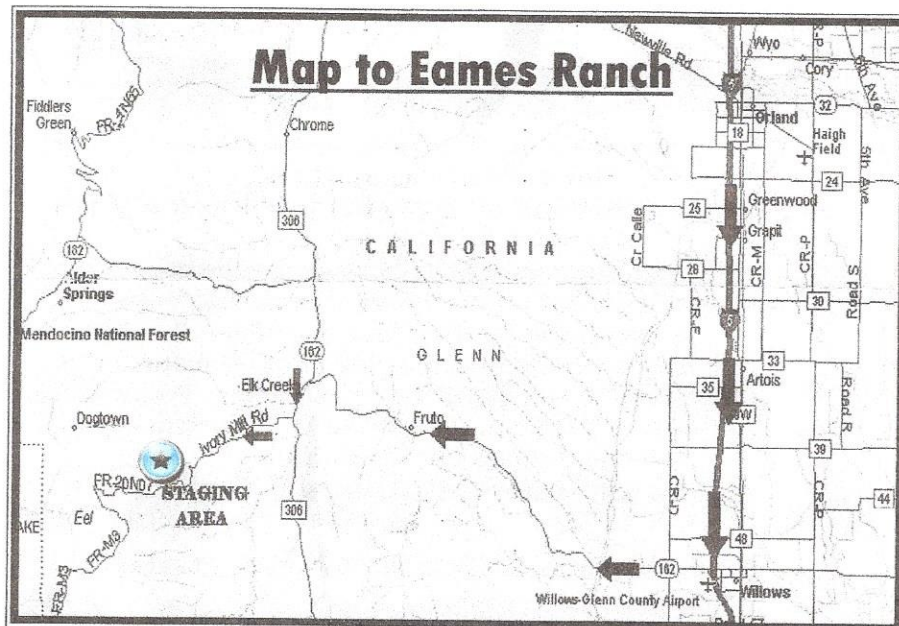

I/We further agree that this waiver, release and assumption of risk is to be binding on my heirs, executors, and assigns.

I/We expressly waive any rights we may have under California State Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know about, or suspect to exist in his favor, at the time of executing the release, which, if known, might have materially affected his settlement with the debtor."

I/We agree to indemnify and hold harmless the GCSP (including all officers, directors, agents, members and employees) and Land Owner and Lessees of Land Owner from any loss, liability, damage, cost, demand, claim, or expense which may be incurred as a result of my participation in this event. This includes all court costs and actual attorney fees arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.
